- I. This includes activity such as bonfires.
- II. The use of a torch or flame-producing device to remove paint from; or seal membrane roofs on, any building or structure.
- III. The occasional use of any non-residential occupancy other than Use Group F, H,or S for group overnight stays of persons over 2 ½ years of age, in accordance with N.J.A.C 5:70-3, the State Fire Prevention Code, section 408.14.
- IV. The use of any open flame or flame-producing device in connection with any public gathering, for purposes of entertainment, amusement, or recreation.
- V. Welding or cutting operations except where the work is performed in an approved area and is covered by a Type B life hazard use.
- VI. The possession or use of explosives or blasting agents other than model rocketry engines.
- VII. The use of any open flame-producing device in connection with training of non-fire service personnel.
- VIII. The occasional use in any building of a <u>multipurpose room</u>, with a maximum permitted occupancy of 100 or more for amusement, entertainment, or mercantile type purposes.
- IX. The storage or handling of Class I flammable liquids in closed containers of aggregate amounts of more than 10 gallons but not more than 660 gallons inside a building, or more than 60 gallons but not more than 660 gallons outside a building.
- X. The storage or handling of Class II or III-A combustible liquids in closed containers of aggregate amounts of more than 25 gallons but not more than 660 gallons inside a building, or more than 60 gallons but not more than 660 gallons outside a building.
- XI. Any permanent cooking operation that requires a suppression system includes <u>Food Trucks</u> in accordance with N.J.A.C. 5:70-4.7(g) and is not defined as a life hazard use in accordance with N.J.A.C. 5:70-2.4.
- XII. The use as a place of public assembly, for a total of not more than 15 days in a calendar year, of a building classified as a commercial farm building under the Uniform Construction Code.
- XIII. The temporary use of any building or portion therefore as a special amusement building for a total of not more than 25 days in a calendar year.
- XIV. The use of tents and temporary tensioned membrane structures without appurtenance.
- XV. The erection, operation or maintenance of any outdoor combustible maze shall require a Type 1 permit if the outdoor combustible maze is less than six feet in height and does not contain electrical equipment.
- XVI. The use of any Group A-4 use, place of worship, as a shelter with a maximum permitted occupant load of 14 persons, for a 14 or fewer consecutive days.
- XVII. Unoccupied of vacant building or structure 2,500 square feet or more, but less than 12,000 square feet, gross floors area.
- XIX Mobile or temporary food preparation activities, where open flame or flame-producing devices or appliances are used, or grease-laden vapors are produced
- XVII The use of any Group A-3 use, place of worship, as a shelter with a maximum permitted occupant load of 14 persons, for 14 or fewer consecutive days, for not more than 49 days in a year in accordance with Section 408.15 of the State Fire Prevention Code

- I. Fumigation or thermal insecticide fogging.
- II. Carnivals and circuses employing mobile enclosed structures used for human occupancy
- III. Using liquefied petroleum gas (LPG or propane), liquefied natural gas, and compressed flammable gas in containers exceeding five pound capacity.
- IV. Unoccupied or vacant buildings or structures 12, 000 square feet or more, but less than 100, 000 square feet, in gross floor area
- V. The storage or retail sales of sparkling devices and novelties in any temporary or permanent structure when pyrotechnic content exceeds 125 pounds.

Type 3 Permit: \$427

- I. Industrial processing ovens or furnaces operating at approximately atmospheric pressures and temperatures not exceeding 1,400 degrees Fahrenheit, which are heated with oil or gas fuel, or which contain flammable vapors from the product being produced.
- II. Wrecking yards, junk yards, outdoor used tire storage, waste material handling plants, and outside storage of forest products not otherwise classified.
- III. The storage or discharge of fireworks.
- IV. Unoccupied or vacant buildings or structures 100,000 square feet or more in gross floor area

<u>Type 4 Permit: \$641</u>

- I. To store or handle, except medicines, beverages, foodstuffs, cosmetics, and other common consumer items, when packaged according to commonly accepted practices, the following sizes and conditions.
 - 1. An amount more than 10 pounds of flammable solids.
 - 2. An amount more than 10 pounds of organic peroxides.
 - 3. An amount more than 1,000 pounds of ammonium nitrate.
 - 4. An amount more than 55 gallons of corrosive liquids.
 - 5. An amount more than 500 pounds of nitromethane.
 - 6. An amount more than one microcurie of radium not contained in a sealed source.
 - 7. An amount more than one millicurie of radium or other radiation material in a sealed source or sources.
 - 8. Any amount of radioactive material for which a specific license from the nuclear regulatory commission is required.
- II. The melting, casting, heat treating, machining, or grinding of more than 10 pounds of magnesium per working day.
- III. The storage, handling, and processing of flammable, combustible, and unstable liquids in closed containers and portable tanks in aggregate amounts of more than 660 gallons.

Type 5 Permit - Reserved
